

Council in Brief – October 4, 2017

Minutes:

Council adopted the minutes of September 13, 2017, as circulated; and the Public Planning minutes of July 21, 2017 as amended. The full set of minutes can be viewed through Council portal on the municipal website.

Reports:

Committee of the Whole Report/Minutes of September 25, 2017 was presented and items adopted included: Receiving the two un-scheduled delegations for information; Report CD.02.2017 regarding Joint Building Services Code of Conduct; Report CLS.17.54 authorizing the signing of the RED contribution agreement; Report CLS.17.55 to establish a Grey Gables Action Working Group; Report CLS.17.56 to authorize the signing of the Connecting Links agreement; Report FIN.17.18 regarding a development charges study; Planning Report PL.17.71 regarding a Site Plan Application; a request from Flesherton Minor Hockey to waive the Kinxplex rental fee for Hockey Day in Flesherton; as well to receive the consent agenda which contained correspondence for information.

Items pulled for further discussion included: The delegation regarding the Kimberley Pond; the rehabilitation of Wellington Street in Feversham to reflect that due to short timelines, cannot be completed within the established timelines and staff be directed to complete the catch basin project at the present time and the rehabilitation project be included in the 2018 budget tender process; Report CLS.17.57 regarding the Council meeting structure to approve option #1a which is to have Council every first and third Wednesday's starting at 1:00pm; and the resolution in support of having the Warden of Grey County be directly elected in 2018.
