**Whereas,** the Municipal Act, 2001 provides that a Municipality may pass by-laws imposing fees or charges on any class of persons; and

**Whereas,** the Planning Act, being Chapter P.13 R.S.O. 1990 as amended, provides that Council may prescribe a tariff of fees for the processing of applications made in respect of planning matters; and

**Whereas,** pursuant to the Building Code Act, 1992, S.O. 1992 c 23 as amended, Council may require the payment of fees on applications for and issuance of building permits and prescribing the amounts thereof; and

**Whereas,** pursuant to the Cemeteries Act (Revised) R.S.O. 1990, chapter C.4 as amended, provided that every owner shall file with the Registrar a price list of all interment rights and cemetery services and supplies that may be sold and all charges that may be made by that owner, approved on January 4, 2006; and

**Whereas,** the Corporation of the Municipality of Grey Highlands deems it expedient to update the fees and charges to be collected by the various departments of the Corporation of the Municipality of Grey Highlands,

**Now Therefore the Council of the Municipality of Grey Highlands hereby enacts as follows:**

- 1. Council hereby establishes the fees and charges as set out in Schedule 'A', Schedule 'B', Schedule 'C', Schedule 'D', Schedule 'E', Schedule 'F', Schedule 'G', Schedule 'H', Schedule 'I', Schedule 'J'; and
- 2. That where this by-law establishes a fee and rate for a fee that has been established in a By-law that pre-dates the effective date of this By-law, the fee and rate in this By-law shall be the applicable fee and rate; and
- 3. That By-law 2012-29 is hereby repealed effective the date of passing of this By-law.

**Definitions**

"Floor Area, Gross (Building)" means, in the case of a building other than a dwelling, it shall mean the aggregate of the area of all floors devoted to retail sales, customer service and/or office use, face of exterior walls but shall not include mezzanine areas, mechanical rooms, common walls, stairwells, garbage and electrical rooms, parking structures and similar uses ancillary to the main use.

"Floor Area, Gross (Dwelling)" means, in the case of a dwelling, the aggregate of the areas of all habitable rooms measured from the exterior faces of the exterior walls but excluding any detached accessory buildings, a breezeway, unenclosed sunroom, porch, and/or verandah, attic, cellar, or basement.

"Floor Area, Gross (Non-Residential)" means, the total floor area of a nonresidential building or structure, including floor levels located above and below grade, measured to the outside face of all exterior walls.

"Major" means a proposal that contains more than 20 units or a proposal that contains a gross floor area of more than 3,000 square metres.

"Minor" means a proposal that contains between 5 units and 20 units or a gross floor area between 1000 and 3000 square metres.

"Small" means a proposal that contains 4 or fewer units or a gross floor area of less than 1000 square metres.

"Unit" means a residential dwelling unit, commercial unit and/or any similar type of unit but does not include a unit within a nursing home or similar institutional facility.

**Notes:**

1. Additional technical review fees may also apply.
2. Fees for multiple applications made at the same time for the same parcel and for the same development proposal for Official Plan Amendments, Zoning By-law Amendments, Minor Variances and Consent applications will be discounted as follows:
  - 1st application – full fee.
  - Subsequent applications (of equal or lesser value) – 50% of full application fee
3. The Pre-consultation fee shall be credited against the subsequent planning application fee.
